



Tactical Initiative


» This proactive tactical initiative by the PORT to "future proof" a critical community asset will:



- Scenario-Based Planning Examine several airline recovery scenarios and work through a range of development options to establish an achievable phased implementation plan.
- Resiliency Evaluate current operational procedures for passenger movements (seat-to-seat) to improve the passengers' experience and position for safe and efficient operations during future public health concerns.
- Cargo Facility Planning Develop plans to capitalize on existing cargo assets and recent evolution of the domestic air cargo market to attract new cargo operations.
- Regional Access and Roadway Planning Coordinate with the MPO and ODOT to synchronize warehousing and cargo trucking routes within the transportation system to enhance Toledo's domestic air cargo business.
- "Highest and Best Use" Land Use Planning Explore new revenue generation opportunities from both aeronautical and non-aeronautical land development to ensure stable revenue streams during turbulent times.

» 2008 Master Plan Forecast vs. 2019 FAA Terminal Area Forecast





Needs and Progress

» Facility needs

- The primary runway, Runway 7/25, does not provide sufficient runway length to accommodate the international cargo flights at 90 percent payload and should be extended.
- The crosswind runway, Runway 16/34, should be extended to meet the FAA recommended 80 percent of the primary runway length.
- The southern portion of Taxiway N should be relocated to meet the FAA recommended design standards for ARC D-IV.
- Relocate the air traffic control tower to provide a clear line of sight to all controlled aircraft maneuvering areas.
- Systematic development of an on-airport industrial and commercial business park is needed.
- Realignment of the south airport access ways to provide the same level of service that currently exists.





